# FC/126/2020 FOOTPATHS, PARKS AND ALLOTMENTS COMMITTEE

To agree the new rules and regulations set out by the committee – AGREED

To discuss the options going forward for a water supply at Burnfoot Allotments and agree which option is best for the Council –

In September 2020 we discovered that some of the allotments were serviced with water, by way of standpipes. This matter was overlooked by both parties at the time of the transfer of the land to us.

We contacted WCF to find out if they knew where the water meter was.

Since that time, investigations have been carried out and it has now been proven that they are supplied via the metered water connection to WCF, and we have determined there are 5 standpipes on the site.

West Cumberland Farmers suggested the following options, but their preferred Option is 1 and 3 as they do not want to deal with the administration of Option 2

- 1. Cut off all the supplies and blank off
- 2. Have individual meters installed to each allotment and re-charge
- 3. Have a new supply installed with new meter

United Utilities have quoted £855.00 for a new connection to the main – see attached appendix. This price will increase on  $1^{st}$  April 2021

In addition, we will need to lay pipework to the connection, and install a standpipe or water trough.

Initial estimates of this work are in the region of 1 to 3k, depending on whether WCF are open to us capping each standpipe. It will be more expensive to find where the supply "T's" off, and disconnect from the main. Nor do we know how many "T" offs there are

The options we have are:

- 1. Do nothing. This is not a preferred option for WCF
- 2. Disconnect the standpipes and blank off A preferred option of WCF disadvantage this would leave tenants without a water supply
- 3. Disconnect the standpipes, blank off, and have United Utilities put in a separate supply to a standpipe or trough
- 4. Put in a water bowser and leave it to WCF to disconnect the standpipes the most cost effective solution for WTC
- 5. Attempt to come to a private arrangement with WCF for water charges

All options were discussed **AGREED** to explore Option 5 with WCF, go back to F & P with information and if not financially viable we agree to Option 4

## FC/127/2020 TREE PLANTING

Cllr Robson had emailed Craig Brough at Hopes asking him if he had any issues with the council improving the land next to the cycle track on West Road with trees etc. and how he felt about the wording of the covenant. Mr Brough's response was that he could get their solicitor to look at the covenant, at a cost of £300 to which he asked the council to pay this. Cllr Robson explained that it wasn't a legal issue as such and again asked if he could see any issues. To date there has been no response. Cllr Robson proposed a letter be sent to Mr Brough from the Town Council to outline our position and invite him to discuss it further. The Clerk to send a letter (drafted by Cllr Robson)

Cllr Robson had received an email from Cumbria Wildlife Trust regarding working with them to create habitats for bees etc. Not sure what it entails as yet but there could be funding available and thought that the area at allotments would be ideal and possibly Phoenix Park, are council happy for him to discuss with them? Yes all happy.
